Presents, Am well and truly indebted to W.T. McCall

in the full and just sum of Seven Hundred & No/100 --- (\$ 700.00) Dollars.

to be paid At the rate of Twenty Five Dollars per month, January 15th 1950 and to run consecutively each month until paid in full. (Payments to begin Jan. 15th 1950) Final payment May 15th 1953.

with interest thereon from Date

at the rate of Five per centum per annum, to be computed and paid Annually

until paid in full: all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said W.T. McCall

All that piece parcel or lot of land lying and situated on the West side of the P & N Railway, in Grove Township, State and County aforesaid in Rehobeth School District, south of Owens Service Station adjoining lands of Mrs. Sunie M Gambrell, S.M. Jones Estate. lands now or formerly owned by C.H. Allen and having the following metes and bounds to wit :-

" Beginning at Post Duke Power line and iron pin on edge of Highway # 29 thence South west direction 160 feet to iron pin, thence in a North east direction 133 feet to edge of Highway # 29 corner of Mrs. Sunie Gambrell property, thence up Highway # 29 from towards Pelzer 98 feet to point of beginning corner.
