WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Hundred Ten and No/100

DOLLARS (\$ 310.00 ),

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the West side of Tubbs Mountain Road and bounded on the south by Bonyan Bowen, on the West by H. McCall, and on the North by other lands of Paul Hunt, containing 3.08 acres and described as follows:

"BEGINNING at a stone and iron pin on west bank of Tubbs Mountain Road at Bowen line and running thence N. 14-30 E. 208.7 feet to iron pipe on west bank of road; thence S. 81-15 W. 767.4 feet to an iron pin in McCall's line; thence S. 24-30 E. 200 feet to iron pin and stone; thence N. 81-15 E. 631.7 feet to the beginning corner."
