TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Frank Bishop (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto The First National Bank, Greenville, S.C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand and No/100

DOLLARS (\$3000.00),

with interest thereon from date at the rate of Six per centum per annum, said principal ~~and interest~~ to be repaid: on May 17, 1950, with interest thereon from date at the rate of Six per cent per annum, to be computed and paid quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northwestern corner of Spruce Street and Poplar Street, near the City of Greenville, being shown as lot No. 9 of Block I on Plat of Woodville Heights, made by W. J. Riddle, in December 1940, recorded in Plat Book K, at Page 274, and described as follows:

"BEGINNING at a stake at the Northwest corner of Poplar and Spruce Streets, and running thence with the Northern side of Poplar Street, N. 79-40 W. 122.9 feet to a stake at corner of lot No. 1; thence with the line of said lot, N. 3-00 E. 80 feet to a stake at corner of lot No. 10; thence with the line of said lot, S. 87-00 E. 221.2 feet to a stake on Spruce Street; thence with the Western side of Spruce Street, S. 3-50 W. 108.6 feet to the beginning corner."

Being the same property conveyed to the mortgagor by H. H. Willis by deed May 6, 1943, by deed recorded in Volume 253 at Page 217.
