Butler Township, Greenville County, State of South Carolina. designated as Tract No. 15 as shown on plat of property of Lucy L. Hindman made by W. J. Riddle, Surveyor, October, 1939, and having the following metes and bounds:

Beginning at an iron pin on the south side of County Road, offset from the center, at the corner of tracts 14 and 15, in line of Tract No. 2, and running thence along the center of said road N. 41-15 E. 326 feet to point in center of said road; thence still with the center of said road, N. 51-30 E. 260.5 feet to point in the center of said County Road, at the corner of Tract No. 16, in the line of Tract No. 1; thence along the line of Tract No. 16, S. 37-15 E. 786 feet to an iron pin at the rear corner of said tract; thence along the line of property of the S. L.
