NOW KNOW ALL MEN, That We, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt wherof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Emil Wagener Allen, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being at the Southwest corner of intersection of East Tallulah Drive and Ioka Street in that area recently annexed to the City of Greenville, County of Greenville, State of South Carolina, being shown as a portion of Lots 35 and 36 on Plat of Property of D. T. Smith, made by C. M. Furman, Jr., Engineer, March 5, 1923, and recorded in the R. M. C. Offic for Greenville County, S. C., in Plat Book "F", at page 108, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest corner of intersection of East Tallulah Drive and Ioka Street, and running thence along the West side of Ioka Street S 25-40 E 200 feet to an iron pin; thence with the line of Lot 37 S 64-20 W 100 feet to an iron pin; thence through Lots 35 and 36 N 25-40 W 200 feet to an iron pin on the South side of East Tallulah Drive; thence along the South side of East Tallulah Drive N 24-20 E 100 feet to the beginning corner.
