All that certain piece, parcel or lot of land on the north side of  
Eighth Street in Section 4 of Judson Mills Village near the City of  
Greenville, in the County of Greenville, State of South Carolina,  
being known and designated as Lot No. 16 as shown on a plat of  
Section No. 4 of Judson Mills Village, made by Dalton & Neves,  
Engineers, January, 1941 recorded in Plat Book K, Pages 75 and 76,  
R. M. C. Office for Greenville County.

Beginning at an iron pin on the north side of Eighth Street, joint  
front corner of Lots No. 15 and 16; thence with line Lot 15, N. 1-42
