TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Etrulia Driskell Gambrell (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-One Hundred and No/100

DOLLARS (\$2100.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: in monthly installments of \$30.00 each on the 18th day of each month, hereafter, beginning April 18, 1950, said payments to be applied first to interest and then to principal until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed semi-annually and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the Northwestern corner of the intersection of Fourth Avenue and Fifth Street, being shown as lot No. 34, Section 2 of Judson Mills Village, as shown on plat made by Dalton and Neves in November 1939, recorded in the R.M.C. Office for Greenville County in Plat Book K at Page 25, and described as follows:

"BEGINNING at a stake at the Northwestern corner of Fourth Avenue and Fifth Street, and running thence with the Western side of Fifth Street, N. 6-07 E. 80 feet to a stake, corner of lot No. 33; thence with lines of lots Nos. 33 and 52, N. 83-53 W. 124 feet to a stake, corner of lot No. 51; thence with line of said lot, S. 6-07 W. 80 feet to a stake on the Northern side of Fifth Street; thence with the Northern side of Fifth Street, S. 83-53 E. 124 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by Ola Hopkins Kay by deed dated November 5, 1941, recorded in Volume 239 at Page 71.
