MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, J. D. Duncan and Sarah Duncan (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand Eighty and No/100

DOLLARS (\$ 1080.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$35.00 on January 15, 1950, and a like payment of \$35.00 on the 15th day of each month thereafter until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid annually.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, in the Town of Travelers Rest at the Eastern corner of Cooper Street and Church Street, being shown as lot No. 12 on plat of the property of Carl R. Vest made by W. P. Morrow in March 1946, and described as follows:

"BEGINNING at a stake at the Eastern corner of Church Street and Cooper Street, and running thence with the Southeastern side of Cooper Street, N. 61-30 E. 100 feet to a stake at corner of lot No. 11; thence with the line of said lot, S. 23-00 E. 148.8 feet to a stake in line of lot No. 13; thence with the line of said lot, S. 61-00 W. 100 feet to a stake on Church Street; thence with the Northeastern side of Church Street, N. 23-00 W. 150 feet to the beginning corner."
