Lot 105 fronting on McMakin Drive in Sans Souci section of Greenville

County, about 2 miles north of the City of Greenville, and shown on

Plat prepared by W. J. Riddle which is recorded in Plat Book K at Page

92, from which the following description is taken:

BEGINNING at an I.P. on the northern edge of a 5' sidewalk running along McMakin Drive which point is the joint front corner of Lots 104 and 105, and running thence along the northern edge of said sidewalk S. 83-55 W. 50' to the joint front corner of Lots 105 and 106; thence along the joint line between these lots N. 5-50 W. 200' to their joint rear corner; thence following the rear line of Lot 5 N. 83-55 E. 50' to the joint rear corner of Lots 104 and 105; thence running the joint line between these lots S. 5-50 E. 200' to the beginning corner.

Said property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of 25 years from the date hereof: (1) Said property is to be used for residential purposes only.
