WHEREAS: I, Charles R. Clay, Jr.

, hereinafter called the Mortgagor, is indebted to

Canal Insurance Company

, a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eighty-Seven Hundred Fifty and No/100 - - -

Dollars (\$ 8750.00), with interest from date at the rate of Four - - - - per centum (4 %) per annum until paid, said principal and interest being payable at the office of Canal Insurance Company

in Greenville, S C., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-Three and 3/100

Dollars (\$ 53.03), commencing on the first day of May, 1950, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 1970.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; on the Southwestern side of Blackburn Street, in the City of Greenville, being shown as lot No. 34 on plat of Isaqueena Park, made by Pickell & Pickell on June 3, 1946, recorded in Plat Book P at Pages 130 and 131, and described as follows:

BEGINNING at a stake on the Southwestern side of Blackburn Street, 75 feet Southeast from Prescott Street, at corner of lot No. 33, and running thence with the line of said lot, S. 51-22 W. 175 feet to a stake in line of lot No. 36; thence with the line of said lot, S. 39-10 E. 75 feet to a stake at corner of lot No. 35; thence with the line of said lot, N. 51-22 E. 175 feet to a stake on Blackburn Street; thence with the Southwestern side of Blackburn Street, N. 39-10 W. 75 feet to the beginning corner.

Being the same property conveyed to the mortgagor by Central Realty Corporation By deed to be recorded herewith.

ALSO, one 30 Gallon Mission Electric Water Heater and one Kresky F.F. 2 72,000 B.T.U. Floor Furnace, it being the intention of the mortgagor that said chattels shall constitute a part of the real estate.
