WE, JAMES R. CULBERSON AND ANNIE M. CULBERSON, of
Greenville, S. C. , hereinafter called the Mortgagor, send (x) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Thirty-one Hundred Fifty - - - -**

(**4 1/2** %) per annum until paid, said principal and interest being payable at the office of General

Nineteen and 94/100 - - - - - Dollars (\$ **19.94**),
commencing on the first day of **May** , 19 **50** , and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **April** , 19 **70** .

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville** ,
State of South Carolina:

situate, lying and being in or near the City of Greenville, Greenville County, South

made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and re-
corded in the R. M. C. Office for Greenville County in Plat Book W, at pages 111-

No. **77** **East Eighth** Street (Avenue) and fronts thereon **58** feet.
