Dollars (\$ 6250.00), with interest from date at the rate of

four per centum (4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co.

in Greenville, S. C., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-seven and 88/100

Dollars (\$ 37.88), commencing on the first day of

June, 19 50, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 70.

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Northwesterly side of Dixie Avenue, in the City of Greenville, South Carolina, being shown as lot 61 on the plat of Dixie Heights as recorded in the RMC Office for Greenville, S. C., in Plat Book "H", page 46, said lot fronting 50 feet on the Northwesterly side of Dixie Avenue and having a depth of 150 feet on the Northeasterly side, a depth of 150 feet on the Southwesterly side and being 50 feet across the rear.
