in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms
of said note, and also in consideration of the further sum of Three Dollars to us, the said
in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of . Graenville, ..and .in . Greenville Township, School District 8-GD, and being known and designated as Lots Nos. 68 and 69, of a subdivision known as "Country Club Estates" as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book G, at pages 190 and 191, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeast side of Augusta Road at the joint corner of Lots Nos. 67 and 68, which point is 60 feet from the southeast corner of the intersection of Augusta Road and Douglass Drive, and running thence along the joint line of said lots, N. 60-47 E. 150 feet to an iron pin at the joint rear corner of said lots in the line of Lot No. 66; thence along the line of said Lot No. 66, S. 29-13 E. 100 feet to an iron pin, joint rear corner of Lots Nos. 69 and 70; thence along the joint line of said lots, S. 60-47 W. 150 feet to the joint corner of said lots on Augusta Road; thence along the line of said Augusta Road, N. 29-13 W. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lots conveyed to us by Mary G. Traxler by deed dated July 17, 1944 and recorded in the R. M. C. office for Greenville County in Deed Book 265, page 353."
