(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$5000.00), with interest thereon from date at the rate of Five (5%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville on the Eastern side of West Faris Road, being known and designated as lot No. 99 on plat of Augusta Circle, made by R. E. Dalton, Engineers, November 1921, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 23, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of West Faris Road, at the joint front corner of lots Nos. 99 and 100, which pin is 99.92 feet North of the Northeastern intersection of Winyah Street and Faris Road, and running thence with the joint lines of said lots, S. 71-35 E. 156.3 feet to an iron pin, joint rear corner of lots Nos. 99 and 100; thence with the rear line of lot No. 84, N. 21-35 E. 50 feet to an iron pin, corner of lot No. 98; thence with the line of lot No. 98, N. 71-35 W. 160.7 feet to an iron pin on the Eastern side of West Faris Road; thence with the Eastern side of West Faris Road, S. 16-30 W. 49.96 feet to the beginning corner."
