BEGINNING 206.8 feet South of the Southeast corner of Wilson Street and Keith Avenue on the east side of Keith Avenue, at corner of lot No. 33; thence with the East side of Keith Avenue, S. 22 E. 56.5 feet to corner of lot No. 31; thence with line of lot No. 31, N. 71-20 E. 144.8 feet to joint corner of lots 31 and 41; thence with rear line of lot 41, N. 15-42 W. ^{56.4} to joint rear corner of lots 41 and 33; thence with line of lot No. 33, S. 71-20 W. 151 feet to the beginning corner.
