Whereas, I the said Julien D. Wyatt
in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to
HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina,
in the full and just sum of Three Thousand and no/100's Dollars,
(\$ 3,000.00) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum
(6%) per annum, to be repaid in installments of Two Hundred and no/100's (\$ 200.00)
Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest
has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and
then to principal; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the
option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's
fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible

sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIATION,
Easley, South Carolina, its successors or assigns:

"ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State
of South Carolina: BEGINNING at an iron pin 500 feet from the parking turn west of Caesar's
head, and running thence with Caesar's Head Drive N. 65-49 W. 100 feet to a stake; thence
S. 6-45 W. 140 feet to the line of the cliff; thence with the line of the cliff 80 feet to a
stake; thence N. 15-40 E. 120 feet to point of beginning, and being Lot No. 66 Section "A",
Development of Caesar's Head as per plat of A. L. Dalton, October 9th, 1924, being the
same property conveyed to Julien D. Wyatt by Hallie McCuen Beckwith and Samuel Cary
