*BEGINNING at an iron pin on the Southwest side of Longview Terrace at the corner of Lot No. 23, and running thence along the line of that lot, S. 20-44 W. 147.1 feet to an iron pin at the rear corner of said lot in the center of a 10-foot strip reserved for utilities; thence along the center of said utility strip, N. 65-45 W. 72.1 feet to an iron pin at the rear corner of the lot belonging to Charles W. Scales, Jr., which point is 2 feet Northwest of the rear corner of Lots Nos. 24 and 25; thence in a Northeasterly direction intersecting the joint line of Lots Nos. 24 and 25, about midway, 143 feet, more or less, to an iron pin on the Southwest side of Longview Terrace, which point is 2 feet Southeast of the corner of Lot No. 25; thence along the Southwest side of Longview Terrace, S. 69-16 E. 68 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
