"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as the Western portion of Lot No. 4 of Block 7 on Plat of Boyce Addition, recorded in Plat Book A at Page 179, and having according to said Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the South side of East North Street, corner of lot No. 3, of Block 7, and running thence with line of lot No. 3, S. 15 E. 126 feet 1 inch to iron pin on a 10 foot alley; thence with said alley, N. 76-45 E. 52 feet to iron pin; thence N. 15-45 W. 126 feet 1 inch to iron pin on South side of East North Street; thence with the South side of East North Street, S. 76-45 W. 52 feet to the beginning corner."
