R. M. C. MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, A. Tilferd Langley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto G. L. Childs (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Hundred and No/100- - -

DOLLARS (\$ 500.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: one year after date with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Randall Terrace, in the City of Greenville; and being the Southern portion of lots 88 and 89 as shown on Plat of Woodside Circle made by C. M. Furman on March 25, 1920, recorded in Plat Book E at Page 219, and described as follows:

"BEGINNING at a stake on the Southern corner of lots 89 and 90, and running thence with the line of said lots in a northeasterly direction 30 feet to a stake; thence N. 66-00 W. 50 feet to a stake in line of lot 87; thence in a Southwesterly direction 30 feet to a stake; thence S. 78-51 E. 50 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by W. B. Dodd by deed to be recorded.

It is understood and agreed that this mortgage is junior in lien to a mortgage held by Fidelity Federal Savings & Loan Association in the original sum of \$1000.00 recorded in Book of Mortgages 452 at Page 89.
