with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: Six months after date, with interest thereon from date at the rate of Five per cent, per annum, to be computed and paid semi-annually.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern corner of Brookwood Drive and Legare Street, in the City of Greenville, being shown as lots No. 27, 28 and 29 of Block D on Plat of Stone Estates, made by C. M. Furman, Jr. in October, 1931, and recorded in Plat Book G at Page 292, and described as follows:

"BEGINNING at a stake at the Northwest corner of Brookwood Drive and Legare Street, and running thence with the Western side of Brookwood Drive, N. 11-22 E. 90 feet to a stake at corner of lot No. 30; thence with the line of said lot, N. 78-38 W. 160 feet to a stake; thence S. 11-22 W. 53.8 feet to a stake on Legare Street; thence with the Northern side of Legare Street, S. 52-30 E. 142 feet to a stake; thence with the curve of the intersection in an Easterly direction following the curve of the intersection, the chord of which is approximately 45 feet to the beginning corner."
