Greenville Township, Greenville County, State of South Carolina. on the South side of Seventh Street in Section 4, Judson Mills Village, near the City of Greenville, S. C., being known and designated as the front portion of Lot 27 as shown by plat of Section 4, Judson Mills, made by Dalton and Neves, January, 1941, which plat is recorded in Greenville County, South Carolina, in Plat Book "K" at pages 75 and 76.

BEGINNING at an iron pin at the intersection of Seventh Street and Hawkins Avenue and running thence with the South side of Seventh Street 79 feet to an iron pin joint front corners of Lots Nos. 27 and 28; thence with the line of Lot No. 28, S. 1-42 E. 79.1 feet to a point on the line if Lot No. 28; thence S. 88-05 W. 89 feet to a point on Hawkins Avenue; thence with the East side of Hawkins Avenue, N. 1-42 W. 69.2 feet to a curve on Hawkins Avenue; thence N. 43-12 E. 14.1 feet to the beginning corner.
