*BEGINNING at an iron pin on the West side of Woodside avenue, 23.3 feet from the Southwest corner of Woodside avenue and Morgan street, and running thence N. 77-07 W. 91.6 feet to an iron pin at the corner of a lot now or formerly of Sloan W.
