I, Herbert N. Hester

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Hundred and No/100- - - - - DOLLARS (\$1500.00), with interest thereon from date at the rate of Six (6%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, containing 78/100 acres, more or less, and being more particularly described:

"BEGINNING at the intersection of the Settlement Road and Hunt's Bridge Road, SE 41° for a distance of 5.13 chains to a NM; thence N. 16-30 E. for a distance of 4.20 chains to a NM; thence SW 80° to OM; thence NW 88° to OM at the intersection of the Settlement Road and Hunt's Bridge Road at the beginning, a distance of 4.66 chains."

Being the same premises conveyed to the mortgagor by Samuel Aiken by deed recorded in Volume 411 at Page 501.
