(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Five Hundred and No/100- - - - - DOLLARS (\$3500.00), with interest thereon from date at the rate of Six (6%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the Southern side of the Old Anderson Road, near the City of Greenville, and being shown as lot No. 18A on plat of Dixie Farms, made by Dalton & Neves in December 1939, recorded in Plat Book L at Page 5 and described as follows:

"BEGINNING at a point in the center of Old Anderson Road at corner of lot No. 18 and running thence S. 35-30 E. 573 feet to a point in the center of a 15 foot drive; at corner of lot No. 24; thence with the line of said lot, N. 63-46 E. 149.4 feet to a stake at corner of lot 19; thence with the line of said lot, N. 32-54 W. 595 feet to a stake in the Old Anderson Road; thence with the center of Old Anderson Road, S. 55-25 W. 175 feet to the beginning corner."
