All that tract or lot of land with buildings and improvements thereon, in Gantt Township, Greenville County, State of South Carolina, about six and one-half miles South of the City of Greenville on the north side of East Gantt Street, and being known as Lot No. 10, as shown on plat of property of Albert Q. Taylor, made by Dalton & Neves, May, 1946, and recorded in the office of the R. M. C. for Greenville County in Plat Book P, Page 49, and having according to said plat, the following metes and bounds, to-wit:
