I, Bertha P. Sisk
State of South Carolina, SEND GREETING: , of the County of Greenville

WHEREAS, I, the said Bertha P. Sisk, Mortgagor, justly and truly indebted to PALMETTO STATE LIFE INSURANCE COMPANY, of Columbia, South Carolina, by my certain promissory note, in writing, dated the 15 day of July, 19 50, in the sum of Ten Thousand and No 100- - - - Dollars, with interest thereon at the rate of (6%) percent per annum, said interest and principal being payable in monthly installments of Ninety-Seven and 60/100- -- Dollars for a period of one Hundred forty-four (144) months, the first payment thereunder to become due and payable on the 1st day of August, 19 50, and the last on the 1st day of July, 19 62,

NOW KNOW ALL MEN, That I, the said mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said PALMETTO STATE LIFE INSURANCE COMPANY according to the terms of the said note and also in consideration of the further sum of Three and no/100 (\$3.00) Dollars to me, the said Bertha P. Sisk mortgagor, in hand well and truly paid by the said PALMETTO STATE LIFE INSURANCE COMPANY at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and sell and release unto said PALMETTO STATE LIFE INSURANCE COMPANY the following described real property:

All that lot of land in Greenville County, State of South Carolina, on the Western side of Hampton Avenue, in the City of Greenville, being known and designated as No. 517 Hampton Avenue, according to the present enumeration of the City of Greenville, and having according to plat made by J. C. Hill dated July 10, 1950, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Hampton Avenue, which pin is 368.3 feet East from Echols Street and running thence with the Southwest side of Hampton Avenue; S. 41-10 E. 89.55 feet to an iron pin; thence S. 41-21 W. 236.5 feet to an iron pin; thence N. 89-45 W. 84.3 feet to an iron pin; thence N. 41-30 E. 247 feet to an iron pin on Hampton Avenue; the point of beginning.
