I, **CHARLES E. ANDERSON**, of Greenville, S. C., hereinafter called the Mortgagor, send (x) greetings:

if not sooner paid, shall be due and payable on the first day of **July**, 19 **70**.

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that piece, parcel or lot of land, with the improvements thereon,
situate, lying and being in or near the City of Greenville, Greenville County, South
Carolina, and being more particularly described as Lot **6**, Section **D**, as

No. **34** **West Eighth** Street (Avenue) and fronts thereon **80** feet.

recorded with this mortgage in the RMC Office for Greenville County, South Carolina.

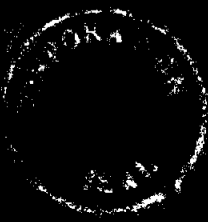
This mortgage is given to secure a portion of the purchase price of the
