TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, J. H. White

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-five Hundred and No/100- - - - -

DOLLARS (\$6500.00), with interest thereon from date at the rate of Six (6%)\* per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Southern side of Easley Bridge Road, known and designated as lot No. 130 on Plat 4 of Camilla Park, which Plat is recorded in Plat Book M at Page 117, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Easley Bridge Road 631.5 feet from the Southeastern intersection of Cole and Easley Bridge Roads, joint corner of lots Nos. 129 and 130; thence along joint line of said lots, S. 21-0 E. 329.7 feet to iron pin, rear joint corner of said lots; thence N. 9-30 E. 160 feet to iron pin; thence N. 30-0 E. 85.3 feet to iron pin; thence N. 48-05 W. 175.4 feet to iron pin in line of Easley Bridge Road; thence along Southern side of Easley Bridge Road, S. 54-23 W. 70 feet to the point of beginning."

Said premises being the same conveyed to the Mortgagor by J. D. Cartee by deed dated March 4, 1949, recorded in Book of Deeds 374 at Page 438.
