(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, School District 7ID, being known and designated as lot 100 as shown on plat No. 3 of Overbrook Land Company, recorded in Plat Book F at Page 218 and described as follows:

"BEGINNING at an iron pin on the Northern side of Lowndes Hill Road, joint front corner of lots 99 and 100, and running thence with joint line of said lots, N. 8-06 E. 179.7 feet to an iron pin; thence N. 89-16 W. 110 feet to an iron pin, joint rear corner of lots 100 and 101; thence with joint line of said lots, S. 8-06 W. 164.5 feet to an iron pin on Northern side of Lowndes Hill Road; thence with said Road, S. 76-44 E. 70 feet to the point of beginning."
