NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing 20.0% acres, and being shown as tract No. 2 on plat of the property of Mary Louise Freeland, made by W. J. Riddle in November 1914, and described as follows:

\*BEGINNING at an iron pin on the East side of a County Road, at joint corner with McPherson property, and running thence S. 46 E. 1617 feet to a stake on branch; thence down branch as a line, E. 57-30 E. 300 feet to a point; thence N. 69-45 E. 511 feet to a stake on branch, the corner of tract heretofore conveyed to J. G. Freeland; thence with the line of said tract, N. 59 W. 2075 feet to line in center of County Road; thence with the center of County Road as a line, S. 19-45 W. 287.1 feet to the point of beginning.\*
