Whereas, we, the said William H. Johnson and Ruby G. Johnson

in and by a certain promissory note in writing, of even date with these

Presents, are well and truly indebted to Farmers Bank of Simpsonville

, to be paid six months after date

, with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid semi-annually, in advance

Farmers Bank of Simpsonville: All that certain piece, parcel or tract of land, situate lying and being in Austin Township, County and State aforesaid, on the Greenville-Woodruff Road in the Old Pilgrim Community adjoining lands now or formerly owned by B. M. Dillard and others, on Gilder Creek, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of the Greenville-Woodruff road, corner of B. M. Dillard land and running thence along said road as a line S. 83 E. 540 ft. to the corner of Davis Property; thence along Davis line S. 6-30 E. 1658 ft. to a point in Gilder Creek; thence a traverse line up the center of Gilder Creek as the line S. 69 W. 173 ft. to bend; thence S. 67-30 W. 161 ft. to bend; thence S. 78 W. 204 ft. to a point in center of said creek (sweet gum tree on bank); thence leaving the creek and following the B. M. Dillard line N. 6-35 W. 1889 ft. to the beginning corner in the Greenville-Woodruff road, containing 23.9 acres more or less, and being the same tract of land conveyed to mortgagors by deed from C.
