"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Western side of Melville Avenue, being shown as Lot No. 13 on Plat of property of Alfrata Calhoun, and being more particularly described as follows:

"BEGINNING at a point on the Western side of Melville Avenue, which point is 796 feet from Augusta Road, and at the joint front corner of Lots Nos. 12 and 13, and running thence with the western side of Melville Avenue 174.9 feet to a point on Melville Avenue; thence N. 6-07 W. 196.6 feet to a pñn at the corner of Lot No. 12; thence with the line of Lot No. 12, S. 72-13 E. 77.3 feet to the point of beginning."
