C. E. Robinson, as Trustee under B. M. McGee Trust Deed, his successors and assigns, forever:

All those pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina, lying and being on the Eastern side of the New Buncombe Road (also known and referred to as Paris Mountain Road and as First Avenue), and being known and designated as Lots 2 and 3 of Block D of Park Place, a subdivision as shown on plat recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "A", Page 119, reference to which plat is hereby made for a more particular description. Said lots have a frontage on the New Buncombe Road of 100 feet and a depth of 150 feet.

The above described property is the same conveyed to me by three deeds, Lot 2 having been conveyed to me by deeds recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 288, Page 444, and 370, Page 6, and Lot 3 having been conveyed to me by deed recorded in Deed Book 322, Page 225.
