"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, School District 1-F, in or near Princeton on the northeast side of the Greenville-Augusta paved highway, containing 1.012 acres, and having, according to a plat of a 2.03 acre lot made by W. M. Nash, Surveyor, November 11, 1933, the following courses: BEGINNING at a point on the northeast side of said highway on the line of Mrs. J. S.
