"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ... Greenville, and in Greenville .Township, being composed of three separate lots of the Ethel Y. Perry property, as shown by two separate plats, Lot No. 4) being shown on plat recorded in the R. M. C. office for Greenville County in Plat Book Q, at page 27, and the other two lots being shown on plat recorded in the R. M. C. office for Greenville County in Plat Book R, at page 127, and having, in the aggregate, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the Northeast corner of the intersection of Dykeson avenue and North Franklin Road, and running thence along the North side of Dykeson avenue, S. 78-30 E. 149.4 feet to an iron pin at the corner of Lot No. 24; thence along the line of Lot No. 24, N. 19-32 E. 86.3 feet to an iron pin at the rear corner of Lots Nos. 3 and 4 (Plat Q, page 27) (shown as Lots 4-a and 3-a, Plat R, page 127), and running thence on a new line across the Southern part of Lot 3, or 3-a, N. 75-15 W. 148 feet to an iron pin on the East side of North Franklin Road, which point is 165 feet South of the intersection of Berkley avenue; thence along the East side of North Franklin Road, S. 19-32 W. 95 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
