per centum per annum, said principal and interest to be repaid as therein stated, and



"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of McDonald Street, in the City of Greenville, known and designated as lot 92, on plat of North Hills, recorded in Plat Book H at Page 138, and having according to said plat the following metes and bounds, to-wit:
