"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Ridgecrest Drive, in the City of Greenville, known and designated as lot No. 33, on plat of Vista Hills, recorded in Plat Book P at Page 39, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Ridgecrest Drive, at the joint front corner of lots 32 and 33, and running thence with line of lot No. 32, S. 39-15 E. 167.5 feet to an iron pin in line of lot No. 35; thence with line of lot No. 35, N. 56-06 E. 80.35 feet to an iron pin, at rear corner of lot 34; thence with line of lot No. 34, N. 39-15 W. 175 feet to an iron pin on Ridgecrest Drive; thence with the Southern side of Ridgecrest Drive, S. 50-45 W. 80 feet to the point of beginning."
