I, Freeman T. Forrester

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Four Thousand and No/100- - - - -** DOLLARS (\$ 4000.00), with interest thereon from date at the rate of **Five (5%) - -** per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Welcome School District, on the Northern side of Welcome Avenue, and being shown as the Southwestern portion of lot No. 81 on Map No. 2 of Camilla Park, recorded in Plat Book M at Page 85, and described as follows:

"BEGINNING at an iron pin on the Northern side of Welcome Avenue, and running thence N. 9-16 E. 224.6 feet to an iron pin; thence through lot No. 81- S. 31-49 E. 171.6 feet to an iron pin on Welcome Avenue; thence with the Northern side of Welcome Avenue, S. 59-30 W. 148.4 feet to an iron pin, point of beginning. "
