All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, being Lot No. 28 on Map No. 1 of Camilla Park, Plat recorded in Plat Book G, page 225, and being on the East side of Beatrice Street, and having the following metes and bounds, to-wit:
