WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, CREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-Five Hundred and No/100- - - - - - - - - - - DOLLARS (\$ 8500.00), with interest thereon from date at the rate of Five (5%)- - - per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, in School District SGD, being known and designated as lot No. 19 as shown on plat of property of J. L. S. Investment Company, recorded in Plat Book D at Page 225, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southern side of West Tallulah Drive, joint front corner of lots 18 and 19, and running thence with joint line of said lots, S. 34-10 E. 198.3 feet to an iron pin; thence S. 55-30 W. 60 feet to an iron pin, joint rear corner of lots 19 and 20; thence with joint line of said lots, N. 34-1 0 E. 198.6 feet to an iron pin on the Southern side of West Tallulah Drive; thence with said Drive, N. 55-50 E. 60 feet to the beginning corner."
