SEND GREETING:

Whereas, I, the said William R. Jameson  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to C. C. Robinson

in the full and just sum of FOURTEEN HUNDRED FIFTY AND NO/100  
to be paid \$800 November 1, 1950,  
\$650 on or before August 1, 1951

with interest thereon from July 29, 1950  
at the rate of 6 per centum per annum, to be computed and paid on principle paying dates  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

fully described as follows:

BEGINNING at a nail and cap in the center of Hart Cut Road and running  
thence S. 83-30 W. 2987.6' to a stone; thence S. 12-45 W. 2095.5' to a  
white oak; thence S. 89-E. 1320' to a spanish oak; thence N. 12 E. 972.2'  
to a stone; thence N. 83-45 E. 1588.1' to a stake; thence N. 50-15 E.  
652' to a nail and cap in said road; thence with road N. 4-20 W. 316' to  
a bend; thence N. 9-45 E. 327' to a bend; thence N. 5-30 W. 348' to a  
nail and cap the beginning corner and containing 116.25 acres more or
