now in the City of Greenville, known as lot No. 2 on plat of property of Bruce & White lands, recorded in Register of Mesne Conveyance for Greenville County, S. C., in Plat Book E, page 58, and described as follows:

BEGINNING at a stake on Austin Street, joint corner of lots 3 and 2, and running thence with said street S. 9-00 E. 39 feet and 4 inches to stake corner lot No. 1; thence with line of lot No. 1, N. 67.5 E. 92 feet to a stake on a 10 foot alley; thence with said alley N. 9.5 W. about 36 feet to a stake, corner lot No. 3; thence with line of lot No. 3, S. 73.5 W. 90 feet to the beginning corner.
