(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$ 5000.00), with interest thereon from date at the rate of Five (5%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of North Avondale Drive (formerly Maple Avenue) in the City of Greenville, being shown as lot No. 24 on plat of property of J. A. and P. F. Cureton, made by Dalton & Neves, in February 1942, and recorded in Plat Book K at Page 113, and described as follows:

"BEGINNING at a stake on the Western side of North Avondale Drive, at corner of lot No. 25, and running thence with the line of lot No. 25, S. 73-50 W. 148.4 feet to stake in line of lot No. 10; thence with line of lot No. 10 and lot No. 9, S. 16-16 E. 60 feet to a stake at corner of lot No. 23; thence with the line of said lot, N. 79-37 E. 150.3 feet to a stake on North Avondale Drive; thence with the Western side of North Avondale Drive, N. 17-00 W. 75 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 415 at Page 326.
