"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of McMakin Drive, known as lot No. 25 and the Eastern one-half of lot 24, on a plat of Dukeland Park, property of Colonia Company, recorded in Plat Book J at Pages 220 and 221, and described as follows:

"BEGINNING at an iron pin on McMakin Drive, at the East front corner of lot No. 25 and running thence N. 81-32 W. 75 feet to the center of the front line of lot No. 24; on McMakin Drive; thence in a parallel line with the joint line of lots 24 and 25, S. 8-28 W. approximately 150 feet to the rear line of lot No. 24; thence N. 85-18 E. 79.3 feet to the Southeast rear corner of lot No. 25; thence N. 8-20 E. 129.4 feet to the beginning corner."
