TO ALL WHOM THESE PRESENTS MAY CONCERN: I, **Collidge Sloan,**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

**SIX HUNDRED**

DOLLARS (\$ 600.00 ), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the

northeast side of the Jordan Road, about seven miles of the City of Greer, S.C., and about two-tenths of a mile south from the W.P. Sloan home place, and more particularly described as follows:

BEGINNING on an iron pin in the center of the Jordan Road, and runs thence in an easterly direction 210 feet to an iron pin in field or orchard; thence in a northerly direction 210 feet to an iron pin; thence in a westerly direction 210 feet to an iron pin in the center of the said Jordan Road; thence along and with the center of said road 210 feet to the beginning corner, and being the same property conveyed to me by W.P. Sloan by deed dated July 21, 1950, to be recorded herewith. Said lot containing one acre, more or less, and bounded on all side by lands of W.P. Sloan.
