grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described

property situated in the county of Greenville State of South Carolina;

All that certain piece, percel or lot of land with the buildings and improvements thereon, lying and being on the Southerly side of Douglass Drive in the City of Greenville, South Carolina, being shown as Lot No. 42 on the plat of Country Club Estates as recorded in the RMC Office for Greenville County, S. C., in Plat Book "G", pages 190-191, said lot fronting 50 feet on the Southerly side of Douglass Drive and having a depth of 130 feet on the Easterly side, a depth of 130 feet on the Westerly side and being 50 feet across the rear.
