with interest from date at the rate of five (5%) per centum per annum until paid; interest to be computed and paid semi-annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I , the said Flora G. Campell

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

South Carolina National Bank, its successors and assigns, forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, shown on Plat of Highland Terrace, Hindman Development compiled from surveys by W. J. Riddle, October, 1936, R. E. Dalton, April, 1936, and known and designated as Lot 15, Block F, as shown on plat recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "K", Pages 120, 121 and 122.

All that lot lying in the Northwest intersection of North Main Street and a 15 foot alley which is bounded as follows:

BEGINNING at intersection of said Street and alley; thence along West edge of said Street, N. 14-47 E. 77.5 feet to corner of Lot 16; thence along joint line of said lots, N. 66-30 W. 190 feet to joint rear corner of Lot 14; thence along line of Lots 14 and 15, S. 14-47 W. 77.5 feet to the edge of said 15 foot alley; thence along said alley, S. 66-30 E. 190 feet to beginning.
