REAL ESTATE MORTGAGE FOR SOUTH CAROLINA

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, the undersigned, L. C. Barker and Inez Barker  
of the County of Greenville, State of South Carolina, hereinafter called Mortgagor, has become justly indebted to the United States of America, acting through the Administrator of the Farmers Home Administration, pursuant to the provisions of Title I of the Bankhead-Jones Farm Tenant Act, as amended, hereinafter called Mortgagee, as evidenced by one certain promissory note, dated the 13<sup>th</sup> day of September, 1950, for the principal sum of One thousand and no/100 dollars (\$ 1,000.00), with interest at the rate of four percent (4%) per annum, principal and interest payable and amortized in installments as therein provided, and in accordance with the terms thereof, the first installment shall be in the amount of \$ 20.00, payable on the 31st day of March, 1951; the next succeeding ~~thirty~~ <sup>thirty-two</sup> installments shall be in the amount of \$ 55.95 each, payable annually thereafter; and the final installment shall be in the amount of any remaining principal and interest payable ~~forty (40)~~ <sup>thirty-two</sup> years from the date of said note; and

WHEREAS, Mortgagor is desirous of securing the prompt payment of said note, and the several installments of principal and interest at maturity, any any extension or renewal thereof, and any agreement supplementary thereto, and any additional indebtedness accruing to Mortgagee on account of any future advances or expenditures made as hereinafter provided, and the performance of each and every covenant and agreement of Mortgagor herein contained;

NOW, THEREFORE, in consideration of the said indebtedness and to secure the prompt payment thereof, as the same matures or becomes due, and of any extension or renewal thereof, or of any agreement supplementary thereto, and to secure the performance of each and every covenant and agreement of Mortgagor herein contained, Mortgagor has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mortgagee the following-described real estate situated in the County of Greenville, State of South Carolina, to wit:

All that land described in real estate mortgage from L. C. Barker to the United States of America, dated Aug. 19, 1945, and recorded in the Clerk's Office, County of Greenville, State of South Carolina in Real Estate Mortgage Book 320, page 287, which description is incorporated herein by reference and made a part hereof.

This real estate mortgage is given subject to the real estate mortgage next above described, and also the real estate mortgage of subject borrower, dated May 6, 1944 in the amount of \$1450.00 and recorded in the Clerk's Office, County of Greenville, State of South Carolina in Real Estate Mortgage Book 326, page 189.
