"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, lying on the South side of Locust to Greer Highway and bounded on the East by Pine Log Ford Road and Moon Land, on South by J. B. Crumpton, on West by Forrester and being lots Nos. 7 and 8 of Plat of Mrs. L. E. Lynn by W. P. Morrow in 1941, and contains 1.52 acres, more or less, and having the following metes and bounds, to-wit:
