TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Francis G. Jenkins (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100- - - - - DOLLARS (\$ 3,000.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about seven miles East of Greenville, containing 8 acres, more or less, according to a survey made by G. A. Ellis, Surveyor, June 1, 1946, and having the following metes and bounds, according to said survey:

"BEGINNING at a stone and iron pin, Walter Wilson's and Frank Cox's corner; thence S. 77-20 E. 518 feet to iron pin on pave road; thence up road, N. 17 W. 252 feet to corner; thence N. 18 W. 321 feet to curve; thence N. 15 W. 200 feet to curve; thence N. 25 W. 100 feet to curve; thence N. 34 W. 100 feet to curve; thence N. 45 1/2 W. 100 feet to curve; thence N. 51 1/2 W. 100 feet to curve; thence N. 60 1/2 W. 103 feet to iron pin; Ponder and Welborn's corner; thence S. 5-45 E. 913 feet to the beginning."

Said premises being the same conveyed to the mortgagor by ~~Frankie~~ W. M. Waldrop by deed recorded in Book of Deeds 295 at Page 346.
